Member DeLaney presented information regarding the Michigan Planning Enabling Act 2008 (MPEA) and the Michigan Zoning Enabling Act 2006 (MZEA) and brought up changes that should be made and/or clarified regarding proper procedures in our Zoning Ordinance. The goal is to keep the township in compliance with state law. Our current workflow does not adhere to the Special Land Use (SLU) ordinance. Members should review our current ordinance (section 14) and discuss / make changes at our next meeting. Member DeLaney also asked Zoning Administrator Kelsey about the process for SLU applications in our township and the others he over sees. ZA Kelsey explained the process as well as the differences between neighboring townships. Reynolds Twp is the only one of the 7 he administers that places the SLU process on the Zoning Administrator. All others work through the Planning Commission and to a lesser degree the Township Clerk. Member DeLaney also stated the township zoning board of appeals (ZBA) is required, according to state law, to have one member from the Planning Commission on the board. Currently there are no members of the PC on the ZBA. Member Westerbrink stated that he would be willing to take that position.
