Treasurer Stedman questioned about paid taxes that received a delinquent notice and who pays the fees & penalties. He responded depends who is at fault. Delinquent notices forwarded to him have been taken care of. Asked about large amount of money in the tax account, Stedman noted settlement from County needs to be distributed.

Due to Covid-19 and extra protocol, the township office will open July 1, with no public restrooms.

Elections for August, due to social distancing, with fewer voting booths, will limit number of voters allowed in building and create much longer lines outside of building. PPE has been ordered in bulk with 3 other townships, splitting cost of approx. \$85.15 per precinct. If social distancing is continued for November election, look into options so more voters will be covered due to anticipated longer lines.
